Thanks to Paul for accepting the position and thanks to Arthur for agreeing to help Paul during the transition period.

Work has already begun to find a substitute and if you have one or more candidates, we will be happy to add them to the list.

CN Pension Committee & CNPA Directors Annual Meeting Year-end 2022 updates

1. The CN Pension Committee met virtually on November 16, 2022 and will thus continue its operations until at least November 2023.
2. In 2020, CNPA has requested training session(s) for NEW and existing committee members. The first such presentation took place on November 10 and was excellent. Over 25 members attended and it educated us on a variety of arrangements. The second session is scheduled for December 1.
3. We also had a pre-meeting with CN and reviewed some concerns and recommendations on the processes and plan provisions. CNPA President Reg Hebert requested to meet in person with the Co-Chair representing the Company in early 2023. At the Committee meeting there was the usual review of all new or ongoing retreats and approvals.
4. INDEXATION 2023 – We have approved the communication that retirees will receive in January. Essentially, eligible retirees will get a 2.46% increase in their monthly payment up to a maximum of \$79.95. The minimum will be \$9.00 and \$4.50 for spouses.
5. CN T4 - Reminder like every year - The CN Income Tax T-4 is MAILED around the END of February and you probably won't receive it until mid-March - so don't call to ask about it unless you haven't received it by the deadline which is the end of March. Want to receive it sooner? - Log in to your account on the CN Pensions and Benefits WEB portal at the following address: <https://cnbenefits.hroffice.com>. If you are not registered, click "Register" and follow the procedure. You will receive your T4 earlier, usually just before the end of February.
6. Financial condition of our CN pension plan – we received a detailed presentation from CN's Investment Division on the financial condition of our pension plan as of early November 2022. It has been a difficult year on the markets, and our regime has also been affected. Our plan has lost approximately 16% of its value since the beginning of the year, mainly due to the decline in the stock and bond markets. In some areas we outperformed market trends and averages, but in others we underperformed. We must also continue to pay our bills. Our pension payments total about \$1 billion a year, which has also been cut from the plan. Our solvency and going concern ratios were very strong at the start of 2022 and, although they will also take a hit, we will most likely come out of this better than other pension funds. We will have these preliminary figures in the spring of 2023.
7. Centenarians - We started the year with 32 potential centenarians from the Quebec region, of which we featured, three died before their date and one was not found, also we have two centenarians in December . We have asked CN for a new list for 2023 and expect it within the next two weeks.
8. Annual Meeting of Directors – November 17-18, 2022 (virtual) Highlights (more details available)

- a. National officers and regional directors participated in this two-day meeting which was well managed and chaired by Reg Hébert. Arthur ST Hilaire, Denis Cousineau, Rémi La Haye, Paul Goupil and our outgoing president Yves Bourdon represented our for the Region. We received reports from all key sectors; Membership, Finance/Budget, Health Care, Government Liaison, Newsletter, Scholarships, Website, CN/CNPAPartnership Agreement, Johnson Insurance, Constitution and Bylaws , etc.
- b. Financially, CNPA is strong and remittances to local councils will continue as they did last year. We are very CONCERNED that some local councils are not contacting the national office and reporting the results of membership recruitment. Audits of local council finances must be completed by MAY 2023 and reported to Rémi Lahaye. We have a NEW Treasurer, Ron Charles from Toronto. We are looking to replace Bruce Peacock as Membership Chair.
- c. C. CNPA Scholarships have been approved for 2023. We should ENCOURAGE all our members to update their address when moving as soon as possible with CN Pensions and Benefits Administration (1 -800-361-0739).
- d. We have done a major cleanup of the National Constitution and Bylaws, which will be distributed in a few weeks. Now is a good time to review and make sure we are sticking to the provisions. We will send highlights when the translation is complete.
- e. The refunded KM has increased to \$0.60.
- f. We encourage you to continue to advertise to all of our retirees who volunteer to receive the added benefit of the Railroaders in the Community program. A new, streamlined national website and a new webmaster will be available in early 2023. The deadlines for national newsletter articles are January 31, June 30 and September 30. We need more articles from our Western Canada.
