The Company (CN) has reached an agreement with the CN Pensioners' Associations (CNPA) to provide mailing addresses periodically. This is so that the pensioner or surviving spouse does not have to make a second call to the National Council.

National Treasurer/ Membership Chairman

It has been said that time ends when one has nothing left to say. Well, here it is time again to put words to paper, and what I have to say is this short message will be my "last" for this publication as I have decided that after 20 years, the time has come to ride into the sunset and allow younger pensioners to take up the challenge and make their plans for the future.

In January of 2002, I was honoured to be elected as your Treasurer. I had accepted this position at a time when the organization was struggling financially. My challenge was to determine a method (or methods) to (a) grow the organization that we all believed to be necessary for the needs of all CN pensioners and survivors and (b) to be sustainable not only for the present, but also for the future.

The analysis did not take long as it was determined that our problem was simply a misconnection with our membership. Those that did retire were well aware that they automatically became "members" of the CNPA; however, the disconnect was that in order to survive as a not-for-profit organization, the missing link was "finances." Every organization needs to have some form of financial income in order to function administratively and effectively. In other words, one would be either a "contributing member" (those who pay \$12 per year) or a "non-contributing member" (those who don't contribute).


The other part of the analysis is that we saw a need for another position to be established (namely a Membership Chairman). This person would oversee a similar position in each of the various Local Councils. It was agreed that I would be that person, so I began my dual role as Treasurer/ Membership Chairman in 2003.

To provide a little history on membership, in the year 2002, we had a retiree population of more than 45,000. Of this total, 11,600 members (or 26%) were "contributing members."

Well, here we are 20 years later, we are still looking after the needs (financially and otherwise) of more than 32,000 pensioners and surviving spouses and our contributing membership has risen to more than 22,800 (or 73%).

And, let me say that I take no credit for this accomplishment. It is credited only to those volunteers from the Atlantic to the Pacific who give of their time and talents unselfishly, and to those retirees and survivors who have listened and responded so positively to our mission, which is to be an association of honesty and integrity; an association that can be called on at any moment of need.

While the profound effects of the pandemic overshadowed much of 2020 and 2021, it also showed the resilience and fortitude within the organization. As the world came to a standstill in March 2020, your volunteers continued to work via an online environment, adjusting their normal practices and, for many, working harder than ever. Membership is still



the life blood of our organization, and now more important than ever as our population steadily decreases. We encourage their survivors and new retirees to become contributing members so that we can continue to provide social activities, literature, health care, scholarships and a host of other benefits; however, the negatives overpower the positives.

It is not time to let up on membership recruiting as the CN Pensioners' Association is the only organization at your disposal to protect the interests of all CN pensioners financially, socially, and emotionally. If you are not a contributing member, I encourage you to become one at your earliest convenience. We have provided everyone with several options for membership as follows:

1. Your retirement package included an application for membership. Simply complete this document and mail it to: National Council of CN Pensioners' Associations Inc. c/o John Wever, National Membership Chairman, 834 Guthrie Dr. W., Sarnia, ON N7V 1Y1. 2. Complete the application and send it back with your pension papers in the same return envelope provided by CN Pensions and Benefits Administration.

3. Complete a membership application on our website (cnpensioners.org).

4. Complete the membership application contained in this newsletter or mail it to: National Council of CN Pensioners' Associations Inc. c/o John Wever, National Membership Chairman, 834 Guthrie Dr. W., Sarnia, ON N7V 1Y1. We appreciate your support, which allows us to continue to work on your behalf throughout your retirement. NOTE to Payroll Deduction Members: Payroll Deduction is a membership continuation process whereby your membership is renewed automatically each year so there is no need to reapply each year.

In closing, it has been a great privilege to serve you and our association as Treasurer/Membership Chairman over these 20 years. Helping our association to flourish has been one of the most meaningful and rewarding endeavours of my life. I encourage each one of you, too, especially our younger members, to find a way that you can volunteer to serve our wonderful family.

HEALTH CARE MATTERS – CHANGING HEALTH CARE PLAN PROVISIONS – YOUR OPTIONS

The **Health Care Plan for CN Pensioners** provides more flexibility than many other similar plans in Canada when it comes to your ability to make changes to your option level of coverage.

We encourage you to review the actual terms and conditions in the annual **Plan Brochure** found on the CNPA National Website – **CNPENSIONERS.ORG** under **Healthcare** and **Blue Cross**.

Each year we write you in **NOVEMBER** to advise you of any changes to the Plan provisions and premiums. During this month of NOVEMBER only, you have the ability to **REDUCE**

your option-level coverage by taking a lower-cost option. This change is effective January 1 of the following year - See page 8 in the Brochure for any restrictions and the details.

IMPROVING your Plan option coverage level is almost unheard of in the healthcare insurance marketplace. But what if your medical conditions change? Under our Plan, and **only within 31 days** of when you turn 60, 65, 70, 75, and so on, you can **IMPROVE** your coverage to a better option with increased coverage or lower deductibles.

William and Mary Gibson craft Circles of Love for their community

CN retiree **Bill Gibson** and his wife of 41 years, Mary, share a love of crafting. One of their favourite projects to do together has been creating colourful wreaths as gifts for family and friends, an activity that has taken on greater meaning and purpose since they were both diagnosed with Alzheimer's disease. "Not only does the repetitive nature of the activity provide a calming effect for my mother and stepfather, but it has also proven to be a wonderful way for them to give back to an organization that has played such an important role in their family's life," says Shelley Sanders, Mary's daughter.

Bill and Mary enjoy spending a few hours every day at the dining room table designing and making their wreaths out of plastic tablecloths for the Alzheimer's Society of Windsor and Essex County (ASWE) in Ontario. Their decorative pieces are used to brighten the homes of people living with dementia, spread cheer around the Day Away Program area and to help raise funds at events to support ASWE services.

"Coming up with appropriate and stimulating activities was crucial for my parents," says Shelley, primary caregiver to the couple. "As a child, my family used to make wreaths from dry cleaning bags and wire coat hangers reshaped into round frames." By introducing something familiar, my mother took to it right away and it didn't take long for Bill to come on board as well."

The tablecloths are cut into strips; Bill separates the pieces and together, he and Mary tie them onto the frames in distinctive patterns. At Bill's insistence, they are also producing environmentally friendly versions from repurposed plastic shopping bags.

Bill, who worked at CN as a Clerk for 40 years in Windsor, ON, before retiring in 1990, invested well over 150 hours making dozens of wreaths for ASWE last year. In recognition of his volunteer time, CN donated \$2,250 to the organization in 2021 as part of the *Railroaders in the Community* program.

"Thanks to the generous support of the CN *Railroaders in the Community* program, these small Circles of Love have created a ripple effect, touching the lives of my parents, our family and our community in a big way," says Shelley.


CN pensioner brightens his community by celebrating his Irish roots

Locomotive engineer **Arthur St-Hilaire** retired from CN in 2006 after 35.5 years of service. "I started in 1970 as a brakeman in Richmond, QC, where I was born, and worked all over the province," says Arthur. "In 1989, I moved out West as an instructor at CN's training centre in Gimli, MB, training employees from Vancouver to Halifax."

Since his retirement, Arthur has stayed in touch with CN through the CN Pensioners' Association (CNPA) where he has held several executive positions, including President of the Richmond Branch, Vice-President for Quebec on the National Council, and representative on the Health and Safety Committee, where he is responsible for the relationship between Blue Cross and the CNPA.

For the past seven years, Arthur has been a volunteer at the Richmond St. Patrick's Society. "My mother's maiden name was Murphy," explains Arthur, "and our Irish roots run deep in the Eastern Townships, where my family still farms the ancestral homestead near Richmond." Among other things, Arthur is one of the directors on the Society's administrative council and is on the organizing committee for the festivities that take place around Saint-Patrick's Day, including the parade through downtown Richmond in which Arthur is a leading participant.

During the summer, Arthur is responsible for the maintenance (mowing the lawn, cleaning and painting the fence) of the Celtic cross erected in Richmond in memory of the Irish immigrants to the region. "Giving back to Richmond is important to me," says Arthur. "No matter where my career at CN took me, and even though I live in Sherbrooke now, I always come back to Richmond. My friends are here, and everyone knows everyone else by their first name." In recognition of Arthur's civic engagement, the CN *Railroaders in the Community* program has provided grants to the Richmond St. Patrick's Society.

CN retiree helps feed his community

Ghislain Nadeau retired from CN's Corporate Services in Montreal in 1997 after 33 years of service. Since then, he has remained very active in his community on the South Shore of Montreal. "I like to remain active and help those less fortunate than myself," says Ghislain. For the past six years, he has been working with Entraide de Saint-Lambert through the Parish of Saint Thomas Aquinas. The organization helps immigrants and refugees integrate into Quebec society by providing French lessons as well as clothing and non-perishable food.

About five years ago, Ghislain also began participating in the Media Food Drive on the South Shore of Montreal with other CN retirees and employees. The Media Food Drive supports 23 organizations, community kitchens and food assistance counters, including Entraide de Saint-Lambert, with food and funding to help people suffering from food insecurity. Ghislain serves on the Media Food Drive's administrative council.

"My wife, Lise, and I like to stay involved in the community in general and greatly appreciate the support of CN and the Railroaders in the Community program" says Ghislain. "We apply for and receive the maximum benefits each year. Last year, Railroaders in the Community donated \$750 to the Media Food Drive and \$2,250 to Entraide de Saint-Lambert in our names. They are most grateful for CN's generous support and give their thanks."

Arlo Fisher is a driving force in his community

While volunteering at a CN Family Day in Moncton, NB, a few years ago, retiree **Arlo Fisher** met another volunteer who would spark his community involvement. That man, a fellow railroader, told Arlo all about Urban and Rural Rides, a volunteer organization that provides safe, reliable and affordable transportation services to get people to medical appointments, to do their shopping and for other appointments.

"I have driven people of all ages to their various doctor's appointments, from older people who can no longer drive to younger adults who, due to a physical condition, cannot drive or do not have a car," says Arlo, who retired as a Manager of Engineering Training in 1991 with over 36 years of service.

"The organization tries to schedule rides efficiently so I drop one passenger off and pick up another nearby but sometimes, it can involve a whole day, such as the time I drove a man to a specialty clinic in Fredericton, waited for him and returned him to Moncton," adds Arlo. "The most frequent request for rides involves taking people from their home to the Peter McKee Food Bank and back. Or picking up food orders from the Albert County Food Bank and delivering the provisions to people in need. There is a real demand for our services because some people have no other way of getting around."

In 2021, Arlo contributed 164 hours of driving to Urban and Rural Rides and drove 4,378 kilometers. In 2022, he is volunteering five days per week and is sometimes accompanied by his wife, Mary Jane. "I am giving back all the gifts of compassion that have been given to me over the years," reflects Arlo. "I have met people from all walks of life who have been grateful for the rides and positive about life in spite of what their circumstances have dealt them. My viewpoint has been changed, as I have gotten out and met people I never would have met."

In recognition of Arlo's volunteer time with Urban and Rural Rides, the organization received a \$2,250 grant from the Railroaders in the Community program last year to support their continued work. "It's a terrific program and I am immensely gratified that my time spent on the road is appreciated by CN, the company with which I spent my entire career," says Arlo.

In certain provinces, provincial drug coverage is enhanced at age 65, so making a Plan option change at age 65 may be appropriate.

It is important that you contact Medavie Blue Cross during this 31-day window otherwise you will not be allowed to make this change. There are certain other unique situations where you may make Plan option changes, all of which can be found on Page 8/9 of the Brochure.

In the event of the **death of a Pensione**r, who is covered, along with their spouse, under our Plan, our Plan covers the surviving spouse for the two months following death. Coverage **terminates** at the end of these two months. If the spouse is eligible to receive a CN pension as a surviving spouse, they will receive a **NEW** Blue Cross application from CN Pensions, and if the surviving spouse is interested in being covered under our Plan they **MUST reapply** for NEW coverage by completing and submitting the Blue Cross form within 60 days. Again, failure to comply with the specified time frames in the Plan brochure will result in denied entry and a loss of coverage.

Once again, I encourage all our Plan members to go to the CNPA website and review the Plan Brochure and the official terms and conditions. You may find items that are covered, that you have not been claiming. You can review the current **Premium Rate sheet** and compare the cost of your option coverage against the cost of other options and the changes to deductibles, etc.

Finally, if you are in **Quebec** and getting close to age 65, you will receive a Blue Cross package from CN Pensions for a one-time opportunity to join our Blue Cross Plan at age 65, which you can use to supplement your RAMQ drug coverage.

RAILWAY MEN FORMALLY OPEN APPLETON CLUB.

Fine Quarters for Veterans of C.N.R - Long Service Medals Presented.

The formal opening of the Appleton Club, the organization of retired Canadian National Railways employees, which was recently formed in this city (Moncton) and named in honour of the general manager of the region, was held yesterday afternoon in the club rooms of the organization in their rooms over the depot.

The General Manager, W.U. Appleton, formally opened the new club and congratulated the members. John Grattan, president of the club, presided at the opening and there was a splendid representation of members on hand to welcome the general manager and other officials who accompanied him. Advantage was taken of the occasion also, to present to five veterans of the railway in this division long service medals, which were recently awarded to them for long and loyal service in the employment of the railway, their combined length of service in the old Intercolonial, the Canadian Government and Canadian National railways being no less than 2ll years.

The recipients of the medals were: John Grattan, formerly mechanical superintendent at Mulgrave; Danford Armstrong, former brakeman at Moncton; R.A. Brown, former station master at Salisbury; Bliss Sears, former conductor at Moncton; and William J. Coffey, former locomotive engineer, Saint John, the latter two presentations being made "in absentia" owing to their inability to be present yesterday. President Grattan, on behalf of the club extended a welcome to General Manager Appleton and the other officials, of the railway who accompanied him, and thanked them for the interest they had taken in the club. He took occasion also to express the thanks of the club for the kindly interest taken in the retired men and their organization by Sir Henry Thornton, president of the railway, and asked the general manager to convey this expression of their feeling to the president.

Mr. Appleton addressed the gathering and said he deeply appreciated

the honour done him by the veterans in naming their club the Appleton Club. He referred to the President's deep interest in the retired employees and of his desire to help them carry on after establishing their clubs.

These clubs, he said, can be of great benefit to the Canadian National Railways, because the members, although not on the active payroll, are still considered employees of the railways and can assist greatly in securing traffic for the national lines.

Mr. Appleton then spoke in a reminiscent vein of his early years in the service and of old associations made then, which he still cherished. He then declared the club formally opened.

Other officials who spoke were the general traffic manager, M.F. Tompkins, general superintendent of transportation, A.C. Barker, general superintendent of motive power, W.E. Barns, general passenger agent, F.W. Robertson, divisional superintendent, W.N. Rippley, superintendent of shops, Joseph Graham, and publicity representative, Horatio C. Crowell. All expressed their gratifications at seeing the club with so healthy membership while yet practically in its infancy.

They hoped that it would continue to flourish and be one of the finest on the system. The club's vice-president, Melvin Steeves, George Moore, and other veterans also gave short speeches, all expressing thanks to the officials for providing such excellent headquarters for them to gather together in social intercourse, and pledging their loyal support at all times to the Canadian National Railways.

Mr. Appleton read the letters from the Home Office in London accompanying the long service decorations and pinned the medals on the breast of each recipient. The veterans decorated made appropriate replies, and following a short social time spent, during which the cigars were passed around, the gathering dispersed after a unanimous vote of thanks to Mr. Appleton and the officials for attending, had been passed on the motion of W.J. Wilcox, seconded by Peter Bannerman.
