Federal Dental Plan.

In December 2023, the Canadian Government outlined seniors' eligibility for the Canada Dental Care Plan (CDCP). The plan will be phased in over time and, by mid-year 2024, many Canadians over 65 were eligible to receive treatment and coverage under the plan.

You can review the provisions, eligibility, timing and how and when to apply online at the Government of Canada website - <https://www.canada.ca/en/services/benefits/dental/dental-care-plan.html>

You should receive a government letter when you are eligible to apply. When you receive the letter:

1. Follow the instructions in the letter to apply by phone.

2. Wait to receive a confirmation from Service Canada that lets you know whether your application was successful and you qualify for the CDCP.

3. If you do qualify, wait to receive your welcome package from Sun Life before scheduling any dental appointments. It will explain further when you can start to get care paid for and how.

NOTE: You must re-apply each year.

If you need help, get a family member to assist you, but make sure you take advantage of this important and valuable benefit. If you still have a general question, you can call Service Canada at 1-833-537-4342.




One of our members has received the Royal Canadian Air Force Association Life Membership Award for his contributions to #700 wing and other military groups over the decades. At 101 years, he is older than the RCAF.

Jim enlisted in the Air Force in 1942 as an air force technician. Starting his training in Moose Jaw then St. Thomas, Ontario, he finished his training in Calgary as an airframe mechanic.

Posted to 1664 Heavy Conversion Unit in Dishforth, Yorkshire, England as part of Six Group, Bomber Command with the RAF, his unit provided conversion training for fighter pilots and crews for 6 Bomber Group RCAF. This upgraded crews to four engine bombers like the Halifax Mk III. In 1945, he was posted to the Pacific Theater but was transferred to the reserve on the surrender of Japan.

Jim and Joy have been long time members of #700 wing. Volunteering and participating in November 11th ceremonies and Battle of Britain parades.





2025 CNPA Scholarship Program

The CNPA Scholarship Program is again available this year. The program provides a \$1500 one-year scholarship for each fall school year.

Eligibility applications are accepted from children, grandchildren, great grandchildren (including legally adopted and stepchildren and step grandchildren) of **CNPA Contributing Members**.

Applications will be accepted beginning April 14 until August 13, 2025. Winners will be contacted by the end of the first week of September 2025.

Note: Applications will be accepted by email only and must include all scanned or electronic supporting documentation as one complete PDF file.

Applicants: Ensure you read ALL the scholarship materials on the website. Applicants must have a minimum 80% grade average over the most recent 2 full academic school years to be considered.

Applicants are assessed based on a combination of their marks and several other important weighted factors such as community involvement, personal and academic achievements, extracurricular activities, career objectives and other relative information provided by the applicant.

National News – April 2025

Did your tax return get flagged for a review? Don't panic, experts say

The Canada Revenue Agency sends tax review letters to about three million taxpayers every year, according to its website, mostly to verify benefits and credits claimed on the return. Generally, he said, reviews aren't serious if a taxpayer has claimed legitimate costs, followed the procedures and has the numbers correct. In most cases, the CRA is looking for more information to verify the tax credits and benefits claimed, such as medical bills or receipts from moving expenses. This is different from a tax audit, which is a comprehensive review of your financial records.

Alberta Government News – March 2025

Enhancing cardiac services in southern Alberta

Alberta's government is accelerating planning for expanded cardiac services in southern Alberta, ensuring Albertans can access the care they need close to home. The plan consists of \$5 million to enhance intensive care services in Lethbridge and Medicine Hat.

Opening more doors to primary care

Budget 2025 includes \$20 million to plan new primary care centres that will improve access to essential services across Alberta.

- There are more than 12,000 registered physicians and more than 68,000 regulated nurses delivering health care services in Alberta.
- Primary Care Alberta's priorities are to:
 - Ensure every Albertan has access to high-quality primary care services across the province.
 - Incentivize care models that improve health outcomes and prioritize patient experience.
 - Support integrated teams of family physicians, nurse practitioners, midwives and pharmacists to provide the best care possible.

Update on Measles situation in Alberta

Alberta's Chief Medical Officer of Health Dr. Mark Joffe issued a statement on the measles situation in Alberta.

"In light of the measles outbreaks across the province, I want to remind all Albertans that these outbreaks are highly preventable. Albertans can protect themselves and those around them by ensuring their measles immunizations are up to date. Immunization with measles-containing vaccine is the single most important public health intervention to prevent measles."

Cases have been reported in all areas of the province but especially the south. If you are not immunized and plan to visit Two Hills, Taber MD, the County of Lethbridge, or the County of Forty Mile, your risk of being exposed to measles is significantly higher than elsewhere in the province.

Bear activity advisory for backcountry and outdoor areas

Alberta Forestry and Parks and Public Safety and Emergency Services are issuing a public safety advisory as bears begin emerging from hibernation across the province.

Anyone spending time outdoors in bear country is urged to take the following precautions:

- Travel in groups and stay on official trails.
- Make noise regularly to avoid surprising a bear.
- Keep dogs on a leash at all times.
- Carry bear spray and know how to use it.
- Store food, garbage and other attractants in bear-resistant containers or facilities.
- Avoid areas with fresh signs of bear activity such as tracks, scat or diggings.
